More assignments are given at the end of lessons and class tests held at regular intervals. The students are informed about the mistakes committed and guided to improve their performance in next examinations. Special tests for slow learners. Each student is encouraged to give seminars in the class. For practicals, keen evaluation of day to day performance of the student for every experiment which includes regularity, procedure, results, viva and promptness in submission of records and the marks obtained are recorded against each experiment. Evaluation is done by the course handling faculty members within one week from the date of examination. The corrected answer scripts at random are verified by HOD to ensure the standard evaluation process. The corrected answer papers of the students are distributed to them for the verification by the students and any grievance is redressed immediately.
